ELEVATOR UPGRADE

THE ELEVATOR WAS INSTALLED IN THE COURTHOUSE IN 2006. RECENTLY, THE CONTROL BOARDS WERE STRUCK BY LIGHTENING WHICH CAUSED THE ELEVATOR TO BE OUT OF SERVICE FOR SEVERAL WEEKS. AT THAT TIME, THE COMMISSIONERS LEARNED THE ELEVATOR CONTROLS WERE IN NEED OF AN UPGRADE. MURPHY ELEVATOR WAS ABLE TO GET THE ELEVATOR REPAIRED AND HAS PROVIDED A QUOTE TO UPGRADE THE ELEVATOR CONTROLS. THE AMOUNT OF THE UPGRADE WILL COST \$90,340.00. COMMISSIONER ROBERTS MADE A MOTION TO MOVE FORWARD WITH HAVING MURPHY ELEVATOR UPGRADE THE ELEVATOR CONTROLS. MOTION WAS SECONDED BY COMMISSIONER EWEN. MOTION PASSED.

HOOSIER HILLS PACT WOMENS SHELTER
